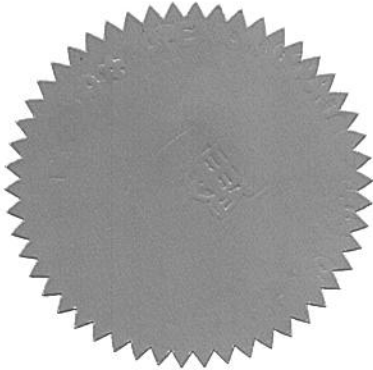

ORDER

THIS MOTION made by Albert Gelman Inc. (“AGI”) in its capacity as Liquidator (the
“Liquidator”) of Tulleidin Investments Limited (“Tulleidin”) for an order amending the Order of

the Honourable Mr. Justice Wilton-Siegel dated April 15, 2014 (the “**April 15, 2014 Order**”), for an order confirming Tulledin’s 50% ownership interest in certain German Bonds, for an order approving the actions of the Liquidator as set out in the Fourth Report of the Liquidator dated December 22, 2014, and for an order approving the fees and disbursements of the Liquidator and its counsel, Blaney McMurtry LLP,

ON READING the Notice of Motion, the Fourth Report of the Liquidator dated December 22, 2014 (the “**Fourth Report**”) and on hearing the submissions of counsel for the Liquidator and all other interested parties,


1. **THIS COURT ORDERS** that the time for service of the Notice of Motion and Motion Record in support of this Motion be and is hereby abridged and that this Motion is properly returnable today, and further that service thereof upon any person other than those set out on the Notice of Motion be and is hereby dispensed with.
2. **THIS COURT ORDERS** that the actions and activities of the Liquidator as set out in the Fourth Report, including the Liquidator’s Interim Statement of Receipts and Disbursements dated December 22, 2014, be and the same are hereby approved.
3. **THIS COURT ORDERS** that the April 15, 2014 Order be and the same is hereby amended as follows:
 - (a) Paragraph 3 of the April 15, 2014 Order is amended by deleting the words, “plus the Liquidator’s estimated fees and disbursements to complete its mandate as Liquidator which are set out in the Liquidator’s Estimated Final Statement of Receipts and Disbursements dated April 3, 2014.”;

- (b) Paragraph 4 of the April 15, 2014 Order is amended to delete the words, “plus the estimated fees and disbursements of Blaney McMurtry LLP to complete its role as counsel for the Liquidator which are set out in the Liquidator’s Estimated Final Statement of Receipts and Disbursements dated April 3, 2014”;
- (c) Paragraphs 5, 6 and 7 of the April 15, 2014 Order shall be deleted.

4. **THIS COURT ORDERS AND DECLARES** that Tulledin owns a 50% interest in 15 German Bonds issued in 1928 and 1930 by the Brandenburg Electric Power Company and the Rhine-Westphalia Electric Power Corporation (the “**German Bonds**”), copies of which are attached to the Fourth Report.

5. **THIS COURT ORDERS AND APPROVES** the fees and disbursements of the Liquidator for the period April 1, 2014, to December 17, 2014.

6. **THIS COURT ORDERS AND APPROVES** the fees and disbursements of the Liquidator’s counsel, Blaney McMurtry LLP, for the period April 1, 2014, to December 22, 2014.
