ORDER

 2. **THIS COURT ORDERS** that the Fourth Report, paragraph 16(a) of the Third Report of the Liquidator dated December 13, 2022, the activities of the Liquidator described therein, and the Liquidator's interim statements of receipts and disbursements for each of the Companies as at August 25, 2023, attached as Appendix "W" to the Fourth Report, are hereby approved, provided, however, that only the Liquidator in its personal capacity and only with respect to its own personal liability, shall be entitled to rely upon or utilize in any way such approval.
 3. **THIS COURT ORDERS** that the fees, costs and expenses of the Liquidator including those of its lawyers, as set out in the Fee Affidavits, are hereby approved, and that the Liquidator is hereby authorized and directed to pay the same from available funds forthwith.
 4. **THIS COURT ORDERS** that Confidential Appendices "A", "B", and "C" to the Fourth Report be and are hereby sealed until the earlier of the delivery of the Liquidator's Certificate pursuant to the Approval and Vesting Order made this day in this Court file, or further Order of the Court.
 5. **THIS COURT ORDERS** that this Order is effective from its date and does not need to be entered.
